

# DR DAVE RUSSELL

'RUSSELL, Dr David Garrett. Dave, you are already so sadly missed.'

O ne paper the editors of a journal always hope they never write while knowing they must, is the tribute to the life of a dear colleague. It is harder when it is for a member of the *Journal's* family; for Dr Dave Russell had accepted the assignment to serve as this *Journal's* Section Editor - Research. We deliberately sought Dave because he was a 'one-of-a-kind' chiropractic academic, that very rare breed who actually wrote papers and published.



We knew he was yet to commence his PhD and we deemed that to be a trivial detail given he has already published more papers than most

chiropractic academics within the chiropractic education environment. To our eyes his 25 or so papers showed his commitment to helping others write and we see this as the measure of the man. He takes first authorship on less than a third of his papers that were indexed at the time of his passing, indicating his mentorship of others to publish.

However he remained modest and considered he simply moved forward by trying to do the best for his profession. We spoke of the time he travelled overseas to present his work at a fund-

raising function and while offered a Business Class airfare which was totally appropriate for the 20 hours or so of flying it would take to get to the destination, plus the same to return, he declined. As he also declined any suggestion of a speaker's fee. He said he felt it '*kind of defeated the purpose*' of the meeting which was, as noted, to raise funds for a chiropractic cause he believed in.

He declined the attempts of Prof Ebrall to recruit him for the new chiropractic program with CQUniversity, however Dr Ross McDonald won him over for *Scotland Chiropractic College*. Please see here; Ross speaks to this below.

It is appropriate to cite how Dave saw himself, and this par is taken from his profile in *Researchgate*, a kind of FaceBook for nerdy academics:

"I am a chiropractor, a curious clinician, in private practice with an interest in the assessment of vertebral subluxation, and how the reduction of vertebral subluxation may impact on human function and quality of life. My investigations and publication interests to date includes individual clinical case reports and series, clinical chiropractic assessment, and population studies."

Vale Dr Dave, friend, colleague, teacher, chiropractor; a curious clinician indeed.

Dave served on the Board between 2014-2017, following many years of volunteering in different aspects of the Foundation. He had a unique skill set - he understood chiropractic principles, the scientific landscape and the research that was required to investigate Subluxation. He also easily built meaningful relationships in a professional capacity. All of these qualities combined to see Dave's achievements and abilities recognised across the world.

He played a critical part in the development and evolution of our two-panel review for Research Expressions of Interest. Being politically aware and always looking to the future, he was one of the Executive who steered the Foundation towards the development of our acclaimed Research Agenda. He continued to support the Foundation, through his ongoing roles in both the Research Agenda Working Committee and Research Committee.

Dave worked tirelessly in representing the Foundation at events in speaking capacities, whether it be fundraising or attracting supporters. Dave was often the conduit between ASRF and the Hamlin Trust (The NZ Research Fund) in cofunding studies, and also a key person in the development of relations between the UCA and ASRF. In fact, he was pivotal in the Foundation reviewing research (out of cycle) for the Board of the UCA, in their decision to fund the study '*Investigating the Effects of Chiropractic Spinal Manipulation on EEG in Stroke Patients.*' (Soon to be published)

Dave loved to teach, and this became very evident during his time at NZCC. In recent years he had stepped up and was a founding Member of the Board of Trustees of the Scotland College of Chiropractic Charitable Trust (SCCCT). He was positioned to become the first President of the Scotland College of Chiropractic in 2021.

Dave was a prolific researcher with many publications to his name. He was always saying that '*If all chiropractors did just one case study in their career, it would help guide the bigger research projects.*' I for one will be endeavouring to do just that.
